11.04 (1)LICENSE REQUIRED. No person shall operate or maintain within the City and public amusement without obtaining a license therefor.(2)PUBLIC AMUSEMENT DEFINED. As used in this section, a public amusement shall include any theatrical performance, exhibition, athletic contest, game or amusement device for which a charge is made for admission or use. "Charge" shall include anything of value. (3)EXEMPTIONS. This section shall not apply to private organizations and associations where the use of the public amusement is restricted to the members thereof or to public amusements owned or operated exclusively for the benefit of educational, charitable or religious institutions, organizations and associations.(4) APPLICATIONS. Applications for licenses shall be made upon forms provided by the Clerk-Treasurer which shall require such information as the City Council may direct. (5) LICENSE FEES. License Fees for public amusements shall be as follows:

Circus/Street Carnival/Menagerie or Side Show \$25/day
Dance hall/Skating Rink/Play or Theatrical Performance including motion picture \$75/year or fraction thereof
Play or Theatrical Performance \$10/day
Billiard/Pool Room \$15/table per year or fraction thereof
Bowling Alley: One Alley \$15/year or fraction thereof; Each Additional \$5 thereof
All other Amusement devices, juke boxes and music boxes \$15/unit per year or fraction thereof
