Waupun Common Council Minutes of Special Meeting Tuesday, June 27, 2017

The Waupun Common Council met in special session on Tuesday, June 27, 2017 at 5:30pm in the Common Council Chambers of the Waupun City Hall with Mayor Nickel presiding.
